General Announcement of Investigations	Mid-November
Notifications of Affected Parties	Late November
Site Visits by Third Party Reviewers	Late November - Early December
Issuance of Preliminary Reports	Early - Mid December
Appeals and Technical Corrections Period	Mid - Late December
Final Reports and Determinations Issued	Early January
Corrective Action Plans	Mid - Late January

# Student Selection Complete

- **December 8**, Student sampled list available to school coordinators
- All 4<sup>th</sup> and 8<sup>th</sup> grade students were selected “take-all situation”
- School Coordinators should do the following:
  - Identify withdrawn or ineligible students
  - Include SD/ELL student accommodations
  - Send out Parent Notifications
  - Manage Questionnaires
- **December 10 -12**, NAEP representative contacts the SC

# NAEP Science Update

- **District of Columbia will participate in the Science testing on a National level**
  - Sample of 4<sup>th</sup>, 8<sup>th</sup>, and 12<sup>th</sup> grade students will take the science assessment instead of math or reading
  - Science results will not be shared on State level, but will be included in National reporting
  - 30% of students in the following schools will take the science assessment: Creative Minds, DC Prep Benning (4), Harmony, KIPP DC Heights, Nalle ES, Oyster Adams, Cardoza, Hart, Meridian
  - 25% of 12<sup>th</sup> grade students from Thurgood Marshall, Woodrow Wilson, and Washington Met will take science assessment
  - Approx. 5% of students from remaining schools will be assessed in science
