Thank you for your continued support and participation in the DC Free Summer Meals Program. Our collaborative efforts to serve nutritious meals to the children of our Nation's Capital have been tremendously successful. So much so , that we were recognized and praised by the USDA's Under Secretary, Kevin Concannon, as being the number one Summer Food Service Program in the Nation for reaching the largest percentage children during the summer months that are eligible to receive free and reduced priced meals through the National School Lunch Program (NSLP). The DC Free Summer Meals Program was also recognized and supported by Mayor Gray for our excellence in service to the children and youth of the District of Columbia. Despite budget cut to summer programming and numerous school closures, our combined efforts, during the summer of 2014, enabled over 1 million healthy and nutritious to be served to children free of charge.

It is essential that children continue to receive sufficient and appropriate nutrition and exercise during the summer months so they may continue to grow stronger in mind and body. This can be done most effectively through your continued participating in Child Nutrition Programs offered by the US Department of Agriculture and administered through the Office of the State Superintendent of Education (OSSE) in the District of Columbia. These programs include the National School Lunch and Breakfast Programs, the Child and Adult Care Food Program, which includes the Afterschool Meal Program and the Summer Food Service Program.

The renewal process was simplified in 2014 for returning sponsoring organization that participated during the preceding year. The State Agency will continue to provide training and technical assistance to our sponsors on food-service operations, nutrition education and guidance on meeting the USDA's Summer Food Service Program requirements as well as the Healthy Schools Act (HSA) requirements of the District of Columbia.

I look forward to working with you again this summer and sharing in the rewarding results we will glean from all the hard work and dedication from administering the DC Free Summer Meals Program and as reflected in the many happy smiles of the children of the District of Columbia...today and tomorrow.
