

2022-23 MID-YEAR MOBILITY BRIEF

Mobility of students refers to students moving into and out of a school during the school year. The DC School Report Card reports the number of entries into and exits from each school each month. This brief provides a systems-level view of entries and exits from each sector and from the District of Columbia overall.

While reviewing the data, please keep the following in mind:

- The Office of the State Superintendent of Education (OSSE) measures mobility from the annual Oct. 5 enrollment audit until May of each year to capture the most reliable enrollment data – enrollments before and after these dates are less reliable because of varying school calendars and the natural transitions that happen at the beginning and end of each school year.
- One student may experience multiple transitions or types of transitions within a single school year.
- OSSE reports mobility based on student enrollment records including entry and exit dates and codes.
- Enrollments in Department of Corrections (DOC) and Department of Youth Rehabilitation Services (DYRS) are excluded from enrollment counts.
- The District of Columbia Public Schools (DCPS) serves as DC's by-right local education agency (LEA) where every child of compulsory age (5) has a right to attend a given school based on their address regardless of the date of enrollment. Each public charter school (PCS) sets their own enrollment policies and determines whether they open available seats via MySchool DC and enroll students throughout the year.
