*A child does not need to be excluded due to these symptoms **IF** the symptom the child is experiencing has been previously evaluated by a healthcare provider and the healthcare provider has provided written or verbal documentation articulating that the specific symptom is not due to COVID-19. Note: Runny nose should be considered for exclusion if it lasts longer than 30 minutes. If the runny nose subsides within 30 minutes (e.g., after playing outdoors), and the individual is not experiencing other COVID-19 symptoms such as a fever or cough, then the individual does not need to be excluded.

^A child does not need to be excluded after close contact if they do not currently have any symptoms consistent with COVID-19 AND they have tested positive for COVID-19 within the last 90 days.

SYMPTOMATIC HOUSEHOLD MEMBERS AWAITING TEST RESULTS: Individuals who have a household member who is awaiting COVID-19 test results after experiencing symptoms of COVID-19 are recommended to not attend child care until the household member receives negative test results.

TRAVEL: Individuals who have traveled in the last 10 days to any place other than Maryland or Virginia are recommended to not attend child care unless they: (1) did not attend child care for 7 days, (2) got tested for COVID-19 3-5 days after returning to DC, AND (3) received a negative COVID-19 viral test.
