New Learning Opportunity for Instructional Leaders

Calling all instructional leaders who want to further their understanding of assessment! If you desire to engage with other professionals to build long-term capacity and support fellow teachers, this may be the right professional opportunity for you.

OSSE invites instructional leaders who currently have a foundational understanding of assessment to participate in a valuable professional learning opportunity. The purpose of this cohort is to build long-term capacity in a cadre of LEA leaders who can then support teachers at their LEAs. This series of workshops, some in-person and some virtual, will take place between additional asynchronous modules, for a total of four workshops.

Test Security

Due: School Test Security Plans!

For schools planning to begin PARCC and/or DC Science testing on April 3rd, which is the first day of the testing window, school test security plans will be due on March 13th. As a reminder, the Quickbase school test security plan application automatically calculates due dates for final school test security plans once intended testing start and end dates have been entered.

Test Security and Administration Tips:

- Secure test materials may not be transported out of school buildings. Once test materials
 have been delivered to a school site, they must remain in a secure location on the
 premises. Please ensure that initial and additional orders of testing materials are ordered
 directly to the school where testing will take place.
- Testing a single session over multiple days is not permitted. If a student's test session is interrupted and they cannot complete the session within the school day, the school must submit an incident report to OSSE and await further guidance from OSSE.

2023 Assessment Monitoring

OSSE is charged with monitoring and overseeing statewide assessment security and administration practices during testing to ensure that assessments are administered securely and under standardized testing conditions.

OSSE will monitor **all** statewide assessments in person beginning in February. The OSSE Assessment Monitoring Checklists for ACCESS, Alt. ACCESS, MSAA, DLM, PARCC and DC Science are now posted on OSSE's Test Security and Test Integrity website. OSSE will select schools for onsite monitoring primarily based on random selection but may also select schools for monitoring based on security or administration issues.

OSSE staff are designated as essential staff and therefore are permitted to enter school buildings as guests. OSSE will not notify schools that have been selected for assessment monitoring and may visit a single school site for multiple assessments. If your school has any health and safety protocols in place, please note them in your school test security plan so that assessment monitors are aware before visiting.

<u>Test Security Training Modules</u>

The Test Security Training Modules are available on the <u>Test Security and Test Integrity Information</u> and <u>Documents</u> section of <u>OSSE's webpage</u>.

These modules are required for all LEA Test Integrity Coordinators, LEA Assessment Managers, LEA Test Coordinators and Nonpublic School Test Coordinators, including those responsible for ACCESS and Alternate ACCESS, MSAA, DLM, DC Science and PARCC.

Upon the completion of all training modules, you will need to complete a quiz and certification form (the first six demographic items listed in the quiz serve as the certification form information), verifying that you have viewed all content.

A score of 80 percent or higher (at least 96 points out of 120 total points) on the quiz will serve as the official attendance and completion of the 2023 Test Security Training.

Note: School test security plans will not be approved if the LEA Assessment Manager or LEA Test Coordinator listed in the plan did not complete the Test Security Training.

OSSE School Test Security Plan Quickbase application: Now Open!

The OSSE School Test Security Plan Quickbase application is now open. The application can be accessed at this link: octo.quickbase.com/db/bmig8feda

All schools participating in statewide summative assessments in the 2022-23 school year are required to submit a school test security plan for each required assessment. Please note that **draft plans** must be entered to inform OSSE of each school's expected testing start and end date for each assessment, which allows the Quickbase application to automatically calculate the due date for the final plan.

Draft Plan Tip!

The first date on your security plan is the first day testing will take place during the testing window. The assessment end date is the final day testing will take place during the testing window. When entering your school's assessment start date, avoid entering the official start and end dates of the testing window into this field, unless those are the dates you will actually begin and end testing.

For example: The ACCESS for ELLs testing window is from Feb. 13 - March 24 and your school plans to administer ACCESS for ELLS testing from Feb. 22 - March 17. The start date of ACCESS for ELLs that should be entered into Quickbase is Feb. 22 and the end date that should be entered into Quickbase is March 17. These are the accurate start and end dates of ACCESS for ELLS administration for your specific school.

Pre-Reporting Data Validation Window

The Pre-Reporting Data Validation window for LEAs in WIDA AMS is from **April 21-April 28**. During this time, LEAs will make corrections to student data before the reporting window. Guidance for LEAs during Data Validation window is forthcoming and will be made available via the NGA Bulletin.

Alternate ACCESS Field Test

The Alternate ACCESS Field Testing window for the District of Columbia is open from **Monday**, **Feb. 13 – Friday**, **March 24**. As a reminder to LEAs, the Field Test is a **mandatory** requirement of administration for the 2022-23 school year.

As a result of this field test, WIDA will produce a redesigned Alternate ACCESS field test that includes a kindergarten form for the 2023-24 school year, as well as an alternate screener.

ACCESS for ELs Online Tickets

As a reminder to Test Coordinators and Test Administrators of the ACCESS for EL's Online assessment, it is **required** that testing tickets be collected after students have logged in to their online test session. These are secure materials that should be stored away once your students have begun testing.

Additional Material Ordering Window

The Additional Materials Ordering Window is **Monday**, **Feb. 6 – Friday**, **March 24**. During this window, you may order additional test materials in WIDA AMS as needed. **Please use the Additional Materials Ordering Tab in WIDA AMS**.

- The initial shipment included extra copies of materials. The extra materials <u>must be used</u> before any orders for additional materials may be placed.
- **Do not dispose of DRC District/School labels until your test window is closed.** If you have a late tester, you will need these labels.
- Additional orders must be placed by District Test Coordinators only. These orders will be shipped directly to the LEA.
- Test Administrators that need additional materials must consult with a District Test Coordinator. This is to determine whether the LEA has the material on hand or whether an order for additional materials may be placed.

MSAA Test Administrator Training

The MSAA Test Administration Training was held on **Wednesday**, **Feb. 1** for Test Coordinators and Test Administrators. You can access the PowerPoint Presentation here as well as view the training video here.

- Test Coordinators will receive access to the MSAA Platform on Monday, Feb. 27.
- Test Coordinators will create all necessary Test Administrator accounts.
- Test Coordinators and Administrators must complete all training modules on the MSAA Platform. Tas must pass the final quiz with 80 percent accuracy. TCs are not required to take the final quiz.
- All MSAA materials are downloaded from the MSAA platform and are to be treated as secure materials.

DLM Administration Updates and Reminders

OSSE completed rostering eligible DLM students in grades 5 and 8 the week of Feb. 13. LEAs and nonpublic schools are responsible for rostering remaining grade 5 and 8 students once Teacher accounts are added, as well as any high school students eligible for the DLM assessment. Video guides for completing this process are available here.

Self-paced DLM Test Administrator training is currently available, and completion of this training is **required** for all new and returning test administrators. Any user assigned the role of Teacher in the

Kite Educator Portal will be automatically enrolled in the required training course. Test Administrators must complete the training and earn at least 80 percent on the embedded quiz to complete pre-administration setup tasks and administer the DLM assessment. Click here for more information.

PARCC & DC Science Technology Coordinator Training

The PARCC & DC Science Technology Coordinator Training was held on Feb. 18. The training provided information about Pearson's technology platforms, including technology setup, and technology tasks to complete before, during, and after testing. PARCC and DC Science Materials Arriving at Schools

School Test Coordinators can expect PARCC and DC Science materials to arrive at schools beginning on March 20. Shipments include test manuals, accommodated test materials, and return shipping materials. Please be aware the PARCC and DC Science materials may ship separately.

When you receive your shipment(s), use the inventory list to ensure that all materials listed were included in the shipment. Once your shipment is inventoried, lock secure testing materials away in the secure location indicated in your school test security plan. If any materials are missing from your shipment, you can place an additional order in PearsonAccessNext, beginning on March
20. Additional orders take about 5 to 8 days from the date ordered to arrive at schools.
