You may recall that your State had a condition placed on your July 1, 2017 grant award because your state failed to meet, its adjusted performance levels for one or more of the section 113(b) core indicators of performance by the 90 percent threshold in section 123(a)(l) of Perkins IV.

The condition placed on your grant award required your State to develop and implement a program improvement plan during the first program year succeeding the program year for which the State failed to meet any State adjusted levels of performance.

I am pleased to inform you that Washington, DC has addressed the required corrective actions and our office has closed your condition that required your State to develop and implement a program improvement plan for core indicator 5P1.

This letter provides follow-up and closure to your Perkins IV monitoring visit on June 6-10 2016. The primary purpose of the visit was to assess your State's compliance with the provisions of the Carl D. Perkins Career and Technical Education Act of 2006 (Perkins IV). The visit was intended to help your State identify possible ways to improve its Perkins administration, implementation, and accountability systems.

With passage of the "The Strengthening Career and Technical Education for the 21st Century Act" (Perkins V), the Office Career, Technical and Adult Education (OCTAE) have conducted a review and reconsideration, of any monitoring findings and suggested improvement strategies that were shared with you and your staff during the monitoring visit.

After some consideration Dr. Sharon Miller, Director, Division of Academic and Technical Education, has determined that any identified monitoring findings are no longer applicable as a result of the recent passage of Perkins V. We are pleased to inform you that our office has closed your State's monitoring findings as your State begins to focus on the implementation of Perkins V.
