

# Test Change Notification: Teacher and School Service Provider Certification

August 1, 2023

# **Background**

The Office of the State Superintendent of Education (OSSE) is offering this guidance document to notify applicants of changes to required exams needed to obtain a DC educator credential(s).

### Scope

This document contains guidance for individuals seeking issuance of an educator credential that authorizes the holder to provide instructional services and support as classroom teachers and student/pupil services providers.

#### **Date Issued**

This guidance was issued on August 1, 2023.

#### Guidance

This notification is to inform applicants that the currently required subject content exams needed to earn OSSE educator certification in the areas listed below are being discontinued by the test provider agency (i.e., Educational Testing Service [ETS]). Consequently, new exams have been adopted to replace the expiring exam(s).

# **Acceptance of Passing Scores**

OSSE has an established passing score(s) recognition schedule for certification exams/tests that have been changed. Test scores for exams previously taken and passed shall be accepted for a period not to exceed three years after the date the previous exam has been discontinued. During this three-year period, applicants shall be permitted to present passing scores for either the new exam or the old exam to meet the testing provisions of OSSE's educator credential requirements.
