

District of Columbia Statewide Assessments Computer-Based Testing Hardship Waiver Application 2015-16 School Year

In 2014-15, 92 percent of all students in the District of Columbia took statewide assessments on computers. In 2015-16, all District of Columbia statewide assessments will be administered on computer, with the exception of paper-based tests required as an accommodation for students with disabilities.

Assessments included are:

- 1. Partnership for Assessment of Readiness for College and Careers (PARCC)
- 2. DC Science Assessment
- 3. ACCESS for English language learners (ELLs)
- 4. DC Alternate Assessments in math and English language arts (NCSC)

To facilitate the successful implementation of computer-based testing across District of Columbia schools, the DC Council has authorized the Office of State Superintendent (OSSE) to allocate the Schools Technology Fund to local education agencies (LEAs). Pursuant to section 10005(c)(3) of the "Revised Revenue Estimate Adjustment Allocation Act of 2013," effective December 24, 2013, (D.C. Law 20-61, D.C. Code § 1-325.251), in fiscal year 2015 and each fiscal year thereafter, OSSE shall distribute any amounts in the fund to LEAs on a per-pupil basis, based on the audited enrollment for the preceding year. LEA allocations for 2015-16 are based on the 2014 enrollment audit and may be used for development and expansion of state of the art technology for innovative learning and educational advancement, including the implementation of Next Generation Assessments.

LEAs that administered PARCC on paper in 2014-15 and are still unable to administer all the above assessments via computer may submit a hardship waiver application (see next page) to OSSE to request students at specified schools be allowed to take the PARCC on paper without an accommodation. This waiver should be an extension of the readiness plans all schools administering PARCC on paper were required to submit in the 2014-15 school year. Hardship waiver applications provided below must be submitted to OSSE.Assessment@dc.gov by December 18, 2015 in order for a waiver application to be considered. OSSE will provide feedback and technical assistance as needed, and issue responses to all waiver requests by January 8, 2016. LEAs applying for a waiver from computer-based testing must demonstrate: (1) how full implementation of computer-based testing presents a significant administrative or educational hardship for the school(s) in identified in the application, and (2) its action plan (including timelines, milestones, and resources) for ensuring full implementation of computer-based testing in all of its schools during the 2016-17 school year.

OSSE will evaluate hardship waiver applications against the enclosed rubric.
