Child Care Rate and Utilization Reporting Period May 2014 – May 2015

Pursuant to the District of Columbia Official Code Section 4-409(e), the Office of the State Superintendent of Education (OSSE) is pleased to provide:

- (1) The impact the cost of living has had on the provision of child care services in the District during the preceding 12 months; and
- (2) The monthly utilization during that same period in each category of child care paid for by the District.

I. Impact of the Cost of Living on Child Care Services in the District

The Child Care and Development Fund (CCDF), as authorized by the Child Care and Development Block Grant Act, is the primary federal funding source devoted to paying for child care for low-income families who work or participate in job training or education. CCDF also provides funding to improve the quality of child care for all children. OSSE is the lead agency for CCDF in the District and is responsible for setting the District's child care provider payment rates every two years. Prior to November 2014, the CCDF required states to use a market rate survey to determine its payment rates. The market rate survey captured the variations in the market rate for child care services across the District rather than capturing the actual costs of providing care. Thereafter, the District was required to use the findings from the market rate survey to set its payment rates as close to the 75th percentile of the market rate to ensure families had access to 75 percent of the child care market in the District of Columbia.

In the Child Care and Development Block Grant Act Reauthorization of 2014, Congress allowed states and the District to use a cost estimation methodology as an alternative to the market rate survey to determine provider payment rates. OSSE selected to use an alternative model and has received approval to do so from Region III's Office of Child Care and DC's State Early Childhood Development Coordinating Council (SECDCC). Unlike the market rate survey, the alternative cost model will take into consideration the key cost drivers in child care: teacher child ratios, group size, and staff compensation and benefits. In addition, the alternative model will also consider the key revenue drivers for child care centers: family tuition and fees, third-party funding (subsidy, Head Start, pre-Kindergarten), full collection of tuition, and enrollment efficiency. The data collected through the alternative model will inform OSSE's tiered reimbursement structure for the child care subsidy program and provide data on the cost of providing high-quality care and how that impacts the child care industry. OSSE's report on the alternative cost model for child care will be completed in September 2015. OSSE will share this model publicly within 30 days of completion.

II. The Monthly Utilization of Child Care Vouchers

Between May 2014 and May 2015, a total of 12,351 child care vouchers¹ were issued to District residents who met eligibility requirements in at least one of the eligibility categories. There are 14


¹ OSSE issued 12,351 childcare vouchers between May 2014 and May 2015. As seen in Appendix 1, approximately 7,500 children were enrolled using these vouchers on a monthly basis. This may appear as a discrepancy, however, this population is very highly mobile and transient, babies are born throughout the year and children age out of the child care sector.

overall eligibility categories that are then further categorized by TANF or Non-TANF, therefore providing a total of 22 eligibility categories.² The 14 overall eligibility categories are:

- (1) Court
- (2) Temporary Assistance For Needy Families (TANF) Countable Act³
- (3) Adult With Disability
- (4) Child With Disability
- (5) Employed (Working Parent)
- (6) Food Stamp
- (7) Foster Care
- (8) Higher Education
- (9) Job Search
- (10) Jobs/Arc (Don't Use) 4
- (11) Protective Services
- (12) TANF Payee
- (13) Teen Parent
- (14) Training Non-TANF
- (15) Vocational Rehabilitation

As shown in the chart below, 90 percent of the families that received child care vouchers during this period were eligible under three categories: employed, training (TANF Countable), and job search.

Appendix I provides the monthly utilization of child care vouchers by eligibility categories for the period of May 2014 through May 2015.

One of OSSE's goals is to ensure the District's youngest and most vulnerable children have access to high-quality early care and education. The alternative cost model approach will help OSSE calculate the cost of quality, based on the provider's type, and help policymakers and other critical stakeholders understand the costs associated with delivering high-quality early care and education services in the District. The data from the cost model report will support more informed decision-making in the District about strategies to achieve our goal of improving child care access and quality.
