# What is the Early Learning Challenge? Quality as Basis for Public Investment

This grant will allow the District to -

 Strengthen infrastructure (standards, assessment, data system)



- Support quality/accountability through a Quality Rating and Improvement System (QRIS)
- Continue to build and develop a great early childhood workforce
- Address the needs of our most vulnerable children and their families

### 5 Areas that Must Be Addressed

- 1. **Successful State Systems** that include: demonstrated commitment to early learning and development; rationale for reform; aligned and coordinated system; and sustainable budget.
- 2. **High-Quality, Accountable Programs** with a statewide, validated QRIS and access to high quality programs for *children with high needs*.
- 3. Promoting Early Learning and Development Outcomes for Children through early learning and development standards, comprehensive assessment system, screening and addressing health, behavioral and developmental needs and family engagement.
- 4. A Great Early Childhood Education Workforce that includes a clear ladder of knowledge and competencies and support for providers to move up that ladder.
- 5. Measuring Outcomes and Progress including kindergarten entry assessment and/or building an early learning data system.

# **Defining our Mission**

Ensure that all District children enter kindergarten healthy and prepared to learn

In order to ensure a clear continuum of service provision, DC will integrate the existing services offered to young children and their families via inter-agency collaboration and strengthened connections between service providers

In order to ensure access to high-quality early care and education for all children birth to five, continue to build capacity for infant and toddler care

In order to ensure continuous quality improvement in all early care and education settings, provide adequate and equitable resources to childcare providers receiving public funds and create accountability mechanisms using the tiered Quality Rating and Improvement System (QRIS)

In order to understand the readiness of young children for school, assess all kindergarteners within the first months of school to gauge their cognitive and socio-emotional development, and health and mental health.
