EMERGENCY ASSISTANCE TO NON-PUBLIC SCHOOLS (EANS) II PROGRAM

The American Rescue Plan (ARP) Act provides \$2.75 billion for the Emergency Assistance for Non-Public Schools (EANS II) Program, which is part of the Governor’s Emergency Education Relief (GEER) Fund. Each state awarded funds is responsible for providing services or assistance to eligible non-public schools to address the impact that coronavirus (COVID-19) has had, and continues to have, on non-public school students and teachers. EANS II funding can be used for “secular, neutral, and non-ideological” services and assistance, including sanitization, personal protective equipment, COVID testing, educational technology, and connectivity.

Nonprofit nonpublic schools are eligible to apply for funding under EANS II if:

- the school was in existence and operated prior to March 13, 2020;
- the school did not and will not apply for and receive a loan under the Small Business Administration’s Payroll Protection Program (PPP) that is made on or after Dec. 27, 2020;
- (NEW) the percentage of students from low-income families in the nonpublic school meets or exceeds 40 percent; and
- (NEW) the nonpublic school serves students from a community or communities most impacted by COVID-19.

The Office of the State Superintendent of Education (OSSE) is providing support and assistance in alignment with federal EANS program guidance. This support and assistance is intended to help non-public schools respond to the pandemic, measure and effectively address significant learning loss, and take other actions to mitigate the impact of COVID-19 on enrolled students and families. Completed applications must be submitted to OSSE by no later than **Friday, November 19, 2021**.

If a non-public school applied for or received a PPP loan prior to Dec. 27, 2020, it remains eligible for the EANS program. Similarly, if a non-public school applies for but does not receive services or assistance through EANS, nothing in the Education Stabilization Fund would preclude that non-public school from applying for and receiving a PPP loan on or after Dec. 27, 2020.

Additional Assurances

The Applicant acknowledges the following:

- Control of funds for services and assistance provided to a non-public school under the EANS program and title to materials, equipment and property purchased with such funds, must be in a public agency, and a public agency must administer such funds, materials, equipment, and property. Therefore, the Office of the State Superintendent of Education (OSSE) will assume ownership and title to all materials, equipment and property purchased using EANS funds.
- Equipment and supplies purchased with EANS funds for students and teachers in a non-public school may be used for the authorized purposes of the EANS program during the period of performance (i.e., through Sept. 30, 2024) or until the equipment and supplies are no longer needed for the purposes of the EANS program (see 34 C.F.R. § 76.661(b); 2 C.F.R. §§ 200.313(a)(1), (c)(1) and 200.314(a)). In general, once equipment or supplies are no longer needed for purposes of the EANS program, an SEA must remove them from the private school. 34 C.F.R. § 76.661(d)(1).
- The school will cooperate with any examination of records by making records available for inspection, production, and examination, and authorized individuals available for interview and examination, upon the request of (i) the Department and/or its Inspector General; (ii) the Office of the State Superintendent of Education and its authorized representatives; or (iii) any other federal or District agency, commission, or department in the lawful exercise of its jurisdiction and authority.
- All services or assistance provided under this program must be secular, neutral, and non-ideological.

Table 2: Commonly used codes and answers to frequently asked questions related to EANS II allowable services and expenses

Services Needed	Accepted Codes	Notes
CLEANING SUPPLIES AND PPE	AA (cleaning supplies for school facilities), AB (PPE—masks and gloves), or AF (hand sanitizer and hand soap)	These are all materials and supplies that are used to clean school facilities, and by individuals for sanitary and protective reasons. Please note: ARP EANS funding cannot be used for cleaning personnel costs.
AIR PURIFICATION	AC	This can be: replacement air filters that are used in existing HVAC systems, portable air purification systems, replacement air filters for portable air purification systems. Please note: ARP EANS funding cannot be used for permanent remodeling.
TRAINING and PROFESSIONAL DEVELOPMENT	AD (training and professional development for staff on sanitization, the use of PPE, and minimizing the spread of infectious diseases), or AI (training and professional development for staff on redeveloping instructional plans for remote or hybrid learning or to address learning loss)	The training can be in person or virtual.
PHYSICAL BARRIERS	AE	Please note: ARP EANS funding cannot be used for permanent remodeling. Barriers must be temporary and removable.

OTHER MATERIALS RECOMMENDED	AF	<p>These are other materials, supplies or equipment recommended by CDC for reopening and operation of school facilities to effectively maintain health and safety. Examples include: signs used to promote social distancing, thermometers, furniture used for social distancing, etc.</p> <p>Please Note: Please use a “Cleaning Supplies and PPE” form for requests for hand sanitizer and hand soap.</p>
CORONAVIRUS TESTING	AG	This includes on site testing as well as reimbursements for students and staff that have been tested elsewhere before arriving at the building.
SOFTWARE and TECHNOLOGY	AH (technology to support remote learning) and AI (addressing learning loss)	Software is considered automated and electronic programs, such as those used to make up for learning loss, facilitate remote learning, or communicate with students.
LEASING	AJ	Please note: ARP EANS funding cannot be used for cleaning personnel costs of leased spaces.
TRANSPORTATION COSTS	AK	These are the transportation costs that specifically fill a need that has been created by the public health emergency. General operating costs are not eligible.
OTHER REQUESTS	AA, AF, AH, AI, and AL	Please use this only if the item being requested does not clearly fit in to another form.

APPENDIX A
Allowable emergency services or assistance under EANS II

A non-public school may request OSSE to use EANS II funds for the expenses of any services or assistance described below:

- AA= Supplies to sanitize, disinfect, and clean school facilities
- AB= Personal Protective Equipment (PPE)
- AC= Improving ventilation systems, including windows or portable air purification systems to ensure healthy air in the non-public school
- AD= Training and professional development for staff on sanitization, the use of PPE, and minimizing the spread of infectious diseases
- AE= Physical barriers to facilitate social distancing
- AF= Other materials, supplies or equipment to implement public health protocols, including guidelines and recommendations from the CDC for the reopening and operation of school facilities to effectively maintain the health and safety of students, educators, and other staff during the qualifying emergency
- AG= Expanding capacity to administer coronavirus testing to effectively monitor and suppress the virus, to conduct surveillance and contact tracing activities, and to support other activities related to coronavirus testing for students, teachers, and staff at the non-public school
- AH= Educational technology (including hardware, software, connectivity, assistive technology, and adaptive equipment) to assist students, educators, and other staff with remote or hybrid learning
- AI= Redeveloping instructional plans, including curriculum development, for remote or hybrid learning or to address learning loss
- AJ= Leasing sites or spaces to ensure social distancing to implement public health protocols, including guidelines and recommendations from the CDC
- AK= Reasonable transportation costs
- AL= Initiating and maintaining education and support services or assistance for remote or hybrid learning or to address learning loss
