



ESSER III-ARP EGMS Application Evidence-Based Interventions

Overview of Requirement

LEAs are federally required to use at least 20 percent of their overall ESSER III-ARP allocation to address learning loss through the implementation of evidence-based interventions that respond to students' academic needs as well as social and emotional needs.

'Evidence-based' means an activity, strategy, or intervention that demonstrates a statistically significant effect on improving student outcomes or other relevant outcomes based on:

- strong evidence from at least one well-designed and well-implemented experimental study (tier 1)
- moderate evidence from at least one well-designed and well-implemented quasi- experimental study (tier 2);
- promising evidence from at least one well-designed and well-implemented correlational study with statistical controls for selection bias (tier 3); or
- demonstrates a rationale based on high-quality research findings or positive evaluation that such activity, strategy, or intervention is likely to improve student outcomes or other relevant outcomes; and includes ongoing efforts to examine the effects of such activity, strategy, or intervention (tier 4).

LEAs must also ensure that these evidence-based interventions address the disproportionate impact of COVID-19 on underrepresented student subgroups:

- Major racial and ethnic groups
- Children from low-income families
- Children with disabilities
- English learners
- Gender
- Migrant students
- Students experiencing homelessness
- Children and youth in foster care

Instructions for Completing This Form
