Independent Accountant's Report

State Superintendent of Education
District of Columbia

We have examined the accompanying Schedules of Student Enrollment and Nonresident Tuition Assessed for the District of Columbia Public Schools (DCPS) and Public Charter Schools (PCS) as of October 5, 2011, as required by DC Code 38-1804.02. The District of Columbia Office of the State Superintendent of Education (OSSE) is responsible for the accompanying schedules. Officials of DCPS and each public charter school are responsible for the enrollment data supporting the accompanying schedules. DCPS and PCS officials did not provide us written assertions about their enrollment data. Our responsibility is to express an opinion as to the accuracy of the enrollment counts reported based on our examination.

Our examination was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants and, accordingly, included examining, on a test basis, evidence supporting the Schedules of Student Enrollment and Nonresident Tuition Assessed and performing such other procedures as we considered necessary in the circumstances. We believe that our examination provides a reasonable basis for our opinion.

Limitation on Verification of Residency

DC Code Section 38-309 requires that documentation be provided when enrolling a student to verify that the student is a resident of the District of Columbia. OSSE has defined the documentation considered to be acceptable for verifying residency and prescribed the use of the Student Residency Verification Form to be used by each school to record that the acceptable documents were provided to the school. The documents evidencing residency are not required to be maintained by the schools; therefore, our examination was limited to review of the Student Residency Verification Form. However, there are material weaknesses in the design of the process and form. First, residency is verified at the school level. Because documents used to prove residency are not required to be maintained, there is no mechanism to determine whether the Student Residency Verification Forms were properly completed. Second, the form designed by OSSE to document that residency was verified is signed only by a school representative. In some instances, the school representative who signs the form is not the person who reviewed the documents, so the signature does not validate that the proper forms of verification were provided. Consequently, there are no controls in the design or operation of the process to ensure that the Student Residency Verification Form was completed only after review of the proper forms of documentation. This lack of control coupled with the fact that a school receives funding based on the number of students who have verified residency and, therefore, has an incentive to deviate

from the guidelines, makes the residency verification process a fraud risk that has no means of detection.

Basis for Qualified Opinion

Our examination disclosed the following deficiencies in student records that resulted in material misstatement of the enrollment data.

The examination found 76,595 students to be enrolled and resident, or nonresident paying tuition, as compared to the 78,200 students included on the Schedule of Student Enrollment for DCPS and PCS. The primary causes of the 1,605 difference were 1) duplicate enrollments, 2) non-attending students, and 3) a difference of 95 students between the total included in the data provided by OSSE and the total of 78,200 reported by OSSE. A duplicate enrollment results when a student has been reported as enrolled at more than one school. Because there is no consolidated student information system used to enroll and track all District students, it is possible for a student to be recorded in more than one system. Also, there is not an effective process for students transferring between schools, primarily between a DCPS school, including nonpublic schools, and a charter school or between two charter schools, to ensure that 1) the withdrawing school is notified timely and 2) the students are withdrawn in the system as of the last date of attendance. The withdrawal date used by most schools is usually the date that the parent officially withdraws the student or the date that the withdrawal was input. Similarly, the enrollment or admission date recorded is typically the date that the related forms were completed rather than the actual first day of attendance. Because the first and last dates of attendance are not used for tracking enrollment, a student can be reported as enrolled in more than one school. Because there are not effective system controls or process controls for students transferring between LEAs (local education agencies), there were 875 student records identified as duplicate in the reported enrollment for DCPS and PCS. Of these, 444 were determined not to be enrolled at October 5, 2011. An additional 1,110 students were found not to be attending as of October 5, 2011, having withdrawn either officially or effectively, *i.e.*, were not officially withdrawn as of the date that they stopped attending. One factor may be that funding is based on membership at October 5th, so students were not removed from the system until after that date. Offsetting the 1,554 students determined not to be enrolled were 202 students identified as enrolled who were not in the October 5th reported enrollment, resulting in a net overstatement of enrollment of 1,352 when compared to the enrollment data or 1,447 when compared to the Schedule of Student Enrollment. In addition, there were 158 students attending without verified District residency, resulting in an enrollment total of 76,595 for DCPS and PCS, exclusive of students in nonpublic and county schools.

The Schedule of Student Enrollment shows 3,605 students reported by OSSE as enrolled in nonpublic and county schools, which was comprised of 1,754 in nonpublic and 1,851 in county. However, this examination verified only 1,716 students enrolled in nonpublic schools and 346 wards enrolled in surrounding county schools. As with the DCPS and PCS schools, duplicate enrollments contributed to the differences. There were 114 student records involving duplicate enrollments. Offsetting the number of students reported by OSSE that could not be verified as enrolled, we identified an additional 136 students attending nonpublic schools and 287 students attending county schools who were not in the numbers reported by OSSE. Of the students found to be attending nonpublic schools, 118 did not have Student Residency Verification Forms on file and were not wards of the District. The process for recording and tracking students in the nonpublic schools on a timely basis is not effective. While the comparison of the reported

enrollment of 1,754 to the verified enrollment of 1,716 is a difference of only 2 percent, this is a net difference. The absolute value of discrepancies is 18%. For wards in county schools, the discrepancy rate was 340%, due primarily to there being no system for recording the general education students placed in county schools. The October 5, 2011, data provided by OSSE consisted of only 95 students, which included none of the general education students.

Opinion

In our opinion, except for the material misstatements described in the preceding paragraphs, the schedules referred to above present, in all material respects, the total number of resident students enrolled as of October 5, 2011, based on criteria described in Note 1.

Other Matter

Our examination was conducted for the purpose of forming an opinion on the accompanying Schedules of Student Enrollment and Nonresident Tuition Assessed. The schedules shown as Attachments 1 through 5, as listed on page 8, are presented for purposes of additional analysis and are not required schedules under DC Code 38-1804.02. The information in such schedules has been subjected to the examination procedures applied in the examination of the Schedule of Student Enrollment, and, in our opinion, except for the effects of the misstatements described in the preceding paragraphs, such information is fairly stated in all material respects in relation to the Schedule of Student Enrollment.

In addition, we noted other matters that we have reported to the Office of the State Superintendent of Education in a separate letter dated January 23, 2012.

This report is intended solely for the information and use of the District of Columbia Office of the State Superintendent of Education, Office of the Mayor, City Council, DCPS Chancellor's Office, and the Public Charter School Board and is not intended to be, and should not be, used by anyone other than these specified parties.

**Notes to the Schedules of Student Enrollment and Nonresident Tuition Assessed
October 5, 2011**

1. Criteria

DC Code 38-1804.02 requires an annual reporting by the Office of the State Superintendent of Education (OSSE) of student enrollment as of October 5th each year. The Schedule of Student Enrollment presents the enrollment calculations required by DC Code 38-1804.02, which includes students attending District of Columbia Public Schools (DCPS) and DC Public Charter Schools (PCS); students placed in nonpublic special education schools by DCPS, OSSE, or a PCS; and students placed by the DC Child and Family Services Agency in surrounding county schools.

DC Code Section 38-309 requires that documentation be provided when enrolling a student to verify that the student is a resident of the District of Columbia. Such verification is required no earlier than April 1 each year in order for a student to be considered properly enrolled. OSSE has issued instructions to the schools as to the documents necessary to verify residency. The amounts of tuition assessed and collected for nonresident students were provided by the DCPS Office of Residency and charter schools with nonresident students. The examination procedures were limited to verifying the nonresident status of the students in the reported enrollment.

Assessment of the accuracy of the enrollment reported by OSSE and student residency verification was based on documents prepared internally by each school. These documents were not subject to verification. The grade level for each student was not included in the examination procedures. The grade levels were reported as provided in the October 5 data provided by OSSE with two exceptions. Special education students shown in the data as “Ungraded” or “CE”, other than those in special education schools, were adjusted to a grade level based upon age ranges provided by OSSE, and students in the DCPS STAY programs were all shown as Adult.

2. OSSE Appeals Process

OSSE has established a process whereby schools have the opportunity to appeal to OSSE for funding for a different number of students than verified by the examination. This appeals process was conducted subsequent to this examination and was based upon different documentation and/or criteria.

It is not uncommon for students to have completed enrollment forms at multiple schools. Given that funding is measured as of enrollment on October 5 each year, it is also not uncommon for dates on enrollment forms to precede October 5 and withdrawal forms to be dated after October 5, regardless of when students began or stopped attending. Therefore, for purposes of this examination, enrollment was determined based on whether a student was attending as of October 5, 2011, rather than the dates of enrollment or withdrawal on forms or recorded in the systems. If enrollment were based on the dates

shown for enrollment and withdrawal without regard to attendance, hundreds of students would be counted as enrolled at multiple schools. During the appeals process, OSSE elected to fund certain students who began attending school after October 5 or had effectively withdrawn prior to October 5, based on the dates of the enrollment and withdrawal paperwork. Although they did not meet the criteria used for the examination, we have included those students as the total number was not material. OSSE granted appeals for 28 students who had effectively withdrawn as of October 5th and 16 students who began school after October 5th.
