OSSE's Commitment



- Fund projects with the highest potential for LEA academic improvement (ROI)
- Evaluate projects in accordance with the SOAR Act guidelines
- Solicit feedback from stakeholders
- Support an innovative approach to school improvement based on LEA needs
- Reduce administrative burdens on LEAs

Significant Changes from Last Year



Reduced funding

- From \$21 million to \$16 million

- Competitive funds
 - All grants with the exception of the Early Childhood grant will be competitive
- Award amounts range from \$100,000-\$250,000 per organization/LEA
 - Exception: Public Facilities grants (\$750,000)
- Supporting early childhood education
 - Formula funding to LEAs with a population of 40% or more 3 and 4 year old students

<u>Extended Learning Time</u>

- Longer School Day
- Extended Week
- Summer Catch-up/Acceleration Sessions

Out of School Time

- Before and After Care Programs
- Homework Clubs
- Afterschool Tutoring

Reducing Administrative Burden



- Coordinated Monitoring of all School Improvement Efforts
 - Alignment to other school improvement strategies (SIG, Title I, RTTT, etc.)
 - Differentiated monitoring based on OSSE's monitoring policy
- One Consolidated SOAR Application
- Comprehensive Approach to School Improvement
- Application Completed Through EGMS

Timeline and Next Steps



- July 30, 2014: Stakeholder feedback session
- August 8, 2014: Deadline for stakeholders to submit comments
- August 22, 2014: OSSE application to the US Department of ED
- Mid-October 2014: Funding available from ED*
- November 2014: Release of NOFA and RFA*
- December 2014: Applications due to OSSE*
- January 2015: Awards to LEAs & support organizations*
