Quality Improvement Network (QIN): The payment rates for infants and toddlers enrolled in a child development facility that is in the QIN shall be as follows:

- (a) The payment rate for infants and toddlers enrolled in a child development home in the QIN shall be eighty-six dollars (\$86.00).
- (b) The payment rate for infants and toddlers enrolled in a child development center in the QIN shall be one hundred dollars and sixty-six cents (\$100.66).

Preliminary: Licensed child development facilities that entered the District of Columbia’s subsidized child care program for the first time after Oct. 1, 2018, receive a Preliminary designation in Capital Quality until they have sufficient valid and reliable observation data to receive an updated rating. The rates for child development centers, homes and expanded homes designated as Preliminary, for traditional, extended day and nontraditional hours of care, shall be as follows:
