### Why is health education important?

It is a well-known fact that healthier students are better learners (Basch, 2010). Research shows that health-risk behaviors such as early sexual initiation, violence, and physical inactivity are consistently linked to poor grades and test scores and lower educational attainment (Carlson et al., 2008; MacLellan, Taylor, & Wood, 2008; Spriggs & Halpern, 2008; Srabstein & Piazza, 2008). The Centers for Disease Control and Prevention (CDC) developed the Whole School, Whole Community, Whole Child model (WSCC) (Figure 1), a model that depicts how the school environment and local community impact the child's academic attainment

and health (Centers for Disease Control and Prevention [CDC], 2015).

Providing students with quality health and physical education and support is a collaborative effort, as it requires coordination between school administrative staff, teachers, parents, and health

care providers, among other adults that may influence students' lives. It is encouraged that partnerships with government agencies, nonprofit organizations, and the private sector be established to work with the school to enhance students' learning experience. The ultimate goal of this menu is to enhance health and physical education by providing the public with resource to live a healthy lifestyle. This will motivate students to adopt positive behaviors during childhood, which is easier and more effective than trying to change unhealthy behaviors during adulthood (CDC, 2015).

### **Helpful Terms**

*Technical Assistance (TA):* the providing of advice, assistance, and training pertaining to the development, implementation, maintenance, and/or evaluation of programs.

*Training of Trainers (TOT):* professional development provided to individuals who are, in turn, responsible for the professional development of others.

Professional Development (PD): a systematic process used to strengthen the knowledge, skills, and attitudes of a particular professional workforce. PD for those who serve adolescents is intended to help improve the health, education, and well-being of youth. This type of PD is consciously designed to actively engage learners and includes the planning, design, marketing, delivery, evaluation, and follow-up of training offerings (events, information sessions, and technical assistance).

Capacity Building Assistance (CBA): the transmission of knowledge and building of skills to improve an organization's ability to achieve its mission. CBA involves using diverse program activities including training, professional development, staff development, technical assistance (see technical assistance), and/or technology transfer

Capacity Building: the process of improving an organization's ability to achieve its mission. It includes increasing skills and knowledge; increasing the ability to plan and implement programs, practices, and policies; increasing the quality, quantity, or cost-effectiveness of programs, practices, and policies; and increasing the sustainability of infrastructure or systems that support programs, practices, and policies.

Cadre of Trainers: a designated, highly proficient core group of individuals who provide professional development to others on particular programs, topics, methods, or skills

### 7. Making Proud Choices! An Adaption For Youth In Out-Of-Home Care

#### 15. Sisters Informing, Healing, Living, and Empowering (SiHLE) Training of Facilitators

Description: Sisters Informing, Healing, Living, and Empowering (SIHLE) is a peer-led, social-skills intervention aimed at reducing HIV sexual risk behavior among sexually active, African American teenage females, ages 14-18. An adaptation of the SISTA intervention, SIHLE emphasizes ethnic and gender pride, and enhances awareness of HIV risk reduction strategies such as abstaining from sex, using condoms consistently, and having fewer sex partners. It consists of four 3-hour sessions, delivered by two peer facilitators (ages 18-21) and one adult facilitator in a community-based setting.

SiHLE sessions are designed for 10-12 African American teenage females. The sessions are gender-specific, culturally relevant and include behavioral skills practice, group discussions, lectures, role-playing, and take-home exercises. SIHLE targets sexually experienced, African American teenage girls (ages 14-18) who are at risk for acquiring or transmitting HIV/STIs.

Since SIHLE is a peer-led intervention, the majority of the activities in each session are facilitated by near peers (18-21 years old) who are co-facilitators with the adult facilitator. Therefore, we strongly recommend that 2-3 staff members (one adult and two near peers) per organization attend SIHLE TOFs: SiHLE training requires group facilitators (or any staff) who will facilitate the SIHLE sessions. At least one of the attendees MUST be a trained near peer facilitator (18-21 years old). The near peer facilitator must have initial facilitator training as well as HIV training (facilitation and HIV 101), or there must be an indication of how this training will occur prior to facilitating the SIHLE intervention.
