\* 5 DCMR §A-2803.6: A nonpublic special education school or program with a probationary certificate of approval may not accept or enroll any additional students from the District of Columbia until OSSE issues a certificate of approval with full approval status.

\*\* 5 DCMR §A-2803.10: A nonpublic special education school or program with a provisional certificate of approval may not accept or enroll any additional students from the District of Columbia until OSSE issues a certificate of approval with full approval status.

\*\*\* Hughes Center's COA is only authorized to serve the following disability categories: Autism, Intellectual Disability, and Multiple Disabilities (Autism or Intellectual Disability and Deaf-blindness, Deafness, Hearing Impairment, Visual Impairment, Orthopedic Impairment, or Other Health Impairment)

5 DCMR §A-2803.3: A nonpublic special education school or program shall operate in a manner consistent with the specifications of the certificate of approval and may not extend, assign, or transfer a certificate of approval status to additional operating sites.

5 DCMR §A-2803.4: A nonpublic special education school or program shall notify OSSE in writing and submit an application to amend its certificate of approval before a change in circumstances occurs. A change in circumstances includes without limitation, a change of ownership, accreditation status, location, or other form of change in operation that is inconsistent with information or specifications submitted to OSSE. If a nonpublic special education school or program expects to experience a change in circumstances, it shall: (a) Notify OSSE in writing at least sixty (60) calendar days before a change in circumstance(s); and (b) Submit to OSSE specific documentation to describe the change, including any additional information requested by OSSE.
