Thank you for your interest in licensing for a child development facility.

According to Title 5-A DCMR, Chapter 1, Child Development Facilities, the Office of the State Superintendent of Education, Division of Early Learning, Licensing and Compliance Unit can issue a license to establish or maintain a child development facility for the care of a child or children under 15 years of age for a period not to exceed three years.

To apply for a license to operate a child development center, the applicant must first complete *OSSE's child development center licensing orientation*. The orientation can be completed in person or through the online licensing webinar. You will receive a certificate which must be submitted with your application. Certificates are given to those individuals who successfully complete the questionnaire at the end of the orientation. Applications submitted without the certificate will not be accepted. After completing the child development center licensing orientation, please complete the attached initial application form, return the application with the applicable license fees, and all required documentation listed on the application form issued by OSSE (5-A DCMR §103.4, §103.5, §108.2).

An application for an initial license shall include a signed declaration by the applicant, or by a person authorized to submit the application on the applicant's behalf if the applicant is not an individual, that the contents of the application and the information provided with it are true, accurate, and complete (5-A DCMR §103.6). An application will not be processed without this information.

Upon receipt of a completed application for an initial license, and prior to the issuance of the license, an on-site inspection will be conducted to determine whether the facility is in compliance with the child development facility regulation (5 A DCMR §103.8). During the initial license inspection a Statement of Deficiencies may be issued if a Facility is out of compliance or is deficient in any way (5A DCMR §103.9). After receipt of notification from the applicant that every stated deficiency has been corrected, a follow-up application review and inspection or inspections as needed will be conducted to determine whether the Facility is in compliance.

You must sign your initial license application form, include the appropriate license fees, and submit a copy of your child development center licensing orientation certificate. Failure to provide a completed application within 90 days of the initial submission may result in your application being denied.
