Dear Colleagues,

I am writing to provide an update on the Office of the State Superintendent of Education (OSSE) policy regarding OSSE's annual monitoring reviews for fiscal year 2022 (FY22) grants.

Due to the influx of Elementary and Secondary School Emergency Relief (ESSER) grants from the Coronavirus Aid, Relief and Economic Security Act (CARES); Coronavirus Response and Relief Supplemental Appropriations Act (CRRSA); and the American Rescue Plan (ARP), OSSE prioritized fiscal monitoring for FY21 grants. Programmatic monitoring was reduced in FY21 in order to minimize administrative burden to local education agencies (LEAs) since all would receive fiscal monitoring.

For FY22 grants, OSSE will resume programmatic monitoring at a level comparable to pre-pandemic monitoring years. Fiscal monitoring will continue this year but will be smaller in scope since all LEAs were fiscally monitored last year.

The purpose of this letter is to provide an update on the key changes that will be implemented this year for programmatic and fiscal monitoring to assist LEAs in planning and preparation.

Overview

OSSE published the original <u>Sub-Recipient Monitoring Policy</u> in 2016, which outlines the monitoring approach and processes of the agency. In this policy, OSSE states that the selection of LEAs for monitoring is based on a minimum of 11 monitoring criteria. Through this assessment, OSSE has historically monitored approximately 10 to 20 LEAs each year. With the unique approach to monitoring that OSSE took last year, OSSE will not use the 11 criteria for the identifying which LEAs to monitor during the 2022-23 school year as stated in the policy.

Selection for Monitoring

OSSE has selected LEAs for FY22 grants monitoring based on a risk assessment focused on LEAs that either had recent findings of noncompliance or those not programmatically monitored in recent years. Selection of LEAs was based on the following:

- If an LEA was programmatically monitored in the past three years (FY19-FY21) and had a
 programmatic finding, they are selected for FY22 grants monitoring.
- If an LEA was not programmatically monitored in the past five years (FY17-FY21) and meets two or more of the following criteria on FY22 grants, they are selected for FY22 grants monitoring:
 - Submitted more than 75 percent of its FY22 reimbursement requests in the last month of the fiscal year or after the close of the fiscal year (i.e., from September–December)
 - Had been open for fewer than five years
 - Had a school designated for school improvement in OSSE's accountability system
 - Had total grant expenditures in the top 75th percentile for FY22

 Demonstrated issues with reporting timeliness and/or application quality across multiple grant programs

Scope of Monitoring

All selected LEAs will receive programmatic monitoring. Additionally, any LEAs selected that have expended ESSER funding in FY22 will receive fiscal monitoring for compliance with procurement requirements only. The following grants may be included in OSSE's monitoring reviews:

- Scholarships for Opportunity and Results (SOAR) Act, Formula
- Scholarships for Opportunity and Results (SOAR) Act, Facilities
- Scholarships for Opportunity and Results (SOAR) Act, Teacher Pipeline
- Coronavirus Aid, Relief, and Economic Security (CARES) Act, Elementary and Secondary School Emergency Relief Fund (ESSER I-CARES)
- Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSA),
 Elementary and Secondary School Emergency Relief Fund (ESSER II-CRRSA).
- Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSA), Elementary and Secondary School Emergency Relief Fund (ESSER II-ARP Equivalent).
- American Rescue Plan, Elementary and Secondary School Emergency Relief Fund (ESSER III-ARP)

Next Steps

- Identify an LEA Point of Contact (POC)
 - Once you receive your monitoring notification from your OSSE monitoring lead, you will be asked to provide the name, email address and phone number of the primary point of contact at your LEA for monitoring.
- Notify Third Party Vendors (if applicable)
 - We encourage you to reach out to any third-party vendors to alert them that their assistance may be needed in providing available fiscal documents.

We will continue to share general updates through the K12 grants newsletter, and you will receive details specific to your LEA in May via email. We look forward to a successful and productive monitoring review.
