



## 2015-2016 OSSE Testing Accommodations SEDS Crosswalk

This resource document compares accommodations available for selection in SEDS before and after the School Year 2015-2016 SEDS Release (September 21, 2015) and distinguishes between what is available as a classroom accommodation versus statewide testing accommodation. Additionally, this crosswalk aligns each SEDS accommodations to its equivalent accommodation, accessibility feature, or administrative consideration on each statewide assessment (PARCC ELA/Literacy, PARCC Mathematics, DC Science Assessment).
