#### CTE Plan Act of 2012 & Strategic Plan

- Legislative Requirements: Calls for a Task Force to develop a city-wide Strategic Plan to improve the quality, structure, and student outcomes of CTE programs in the District.
- Outcomes:
  - Task Force Convened Regularly August-December
  - Submitted Strategic Plan to Mayor Gray in mid-December
  - Inter-Agency Team Currently Working on Implementation

#### **7 STRATEGIES WITHIN THE CTE STRATEGIC PLAN**

Strategy 1: Ensure that CTE Programs offered by LEAs and UDC-CC align to the District's Priority Career Sectors.



#### CTE Plan Act of 2012 & Strategic Plan

- Strategy 2: Establish rigorous, required standards of program quality.
- Strategy 3: Encourage and support LEAs and UDC-CC in establishing:
  - A CTE data collection system and process
  - Career awareness, exploration, and preparation programs beginning in middle school
  - Effective partnerships with the business and community
- Strategy 4: Support LEAs and UDC-CC in streamlining their resources by establishing partnerships to allow their students to take CTE courses on school campuses other than their own without requiring a change in their enrollment.
- Strategy 5: Afford LEAs and UDC-CC flexibility in identifying, hiring, compensating, and scheduling the most effective CTE teachers for their students.
- Strategy 6: Reengage the District's Disconnected Youth through CTE Programs that can prepare them for successful careers.
- Strategy 7: Increase and improve CTE Program offerings for adult District residents.

# **Dual Enrollment Regulations & Fund**

- Dual enrollment programs enables high school students to enroll in approved college courses, taken on a college campus, and to simultaneously earn high school and college credit.
- Dual Enrollment Regulations encourage LEAs and Postsecondary Institutions to Develop New, or Expand Existing Dual Enrollment Programs, through:
  - Allowing students to receive dual credit
  - Allowing LEAs to award dual enrollment students the same grade weight as AP/IB
  - Establishing Dual Enrollment Partnership Agreement Template (guidance)
  - Dual Enrollment Fund
