

# DC Providers: Need to meet the OSSE Health and Safety Training Requirements by September 30, 2017

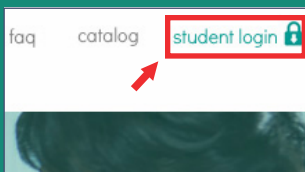


## You can do this online through Quorum!

OSSE Required Health and Safety Training Topics	Quorum Courses that meet Requirements (6 courses)
<ul style="list-style-type: none"> <li>Prevention and control of infectious diseases, including immunization</li> <li>Administration of medication, consistent with standards for parental or guardian consent</li> </ul>	<p>Cut the Cooties: Communicable Disease Prevention <i>(2 hours)</i></p>
<ul style="list-style-type: none"> <li>Prevention of sudden infant death syndrome and use of safe sleep practices, if serving infants/toddlers</li> </ul>	<p>Safe Sleep &amp; Sweet Dreams for Infants <i>(2 hours)</i></p>
<ul style="list-style-type: none"> <li>Prevention of and response to emergencies due to food and allergic reactions</li> </ul>	<p>From Food to Physical Activity <i>(4 hours)</i></p>
<ul style="list-style-type: none"> <li>Child abuse and neglect, prevention, detection and reporting</li> <li>Prevention of shaken baby syndrome and abusive head trauma, as applicable</li> </ul>	<p>Understanding Child Abuse &amp; Prevention <i>(3 hours)</i></p>
<ul style="list-style-type: none"> <li>Building and physical premises safety, including identification of and protection from hazards that can cause bodily injury such as electrical hazards, bodies of water, and vehicular traffic</li> <li>Emergency preparation and response planning for emergencies resulting from a natural disaster or a human-caused event</li> <li>Poison prevention, including the handling and storage of hazardous materials and the appropriate disposal of bio contaminants</li> </ul>	<p>Keeping Our Children Safe: Planning Ahead and Being Prepared <i>(4 hours)</i></p>
<ul style="list-style-type: none"> <li>Transportation safety</li> </ul>	<p>Traveling with Precious Cargo <i>(3 hours) Only required if transporting children</i></p>
<ul style="list-style-type: none"> <li>First aid and CPR</li> </ul>	<p><b>Must be completed at an in-person training</b></p>
<p>*Developmentally appropriate programming for infants, toddlers, preschool, and/or school-age children, as applicable</p>	<p>Quorum offers multiple courses for this topic <i>(8 hours required) *This requirement must be met within one year of hiring date</i></p>
<p>*Identifying, approaching, and referring students showing signs of psychological distress to appropriate support services</p>	<p>Unavailable online <i>*This requirement must be met within one year of hiring date</i></p>

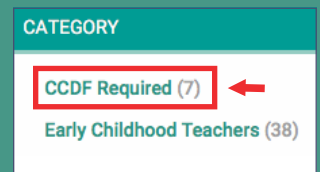


**Step 1:** Select student login
