INFORMATION FROM LEAS

Your LEA's contact person(s). These individuals will receive email updates regarding the ADT process, and will make decisions regarding the ADT. In selecting this person, consider: Can s/he tell OSSE staff about your SIS setup, student data, and the computer selected for ADT installation? Contacts can include IT staff, registrars, and data managers, and you may list multiple staff, but be prepared to have one person speak for your LEA as a decision-maker.

Student Information System information. To properly install the ADT, OSSE needs to confirm: the SIS used at your LEA (e.g. PowerSchool, SchoolForce); the number of campuses and buildings for your LEA for SY2014-2015 and the SIS used at each; and whether your SIS is hosted locally, by the vendor, or a third party.

Register for both webinars. The webinars are appropriate for data managers, registrars, IT staff, and any interested LEA staff that work with data on a regular basis.
