## **Community Schools: Grant Updates**

### **EOY Reports**

All EOY reports were received by specified due date, Sept. 9, 2016. Reports will be shared with evaluators to incorporate in their evaluation of grantees.

### Fiscal year 2017 (FY 17) Continuation Application

Grant applications for FY 2017 Community Schools continuation application was released in OSSE's Enterprise Grant Management System (EGMS) on Sept. 7, 2016. Continuation applications are due in EGMS by Sept. 23, 2016.



## The Every Student Succeeds Act

- Reauthorized the Elementary and Secondary Education Act (ESEA) in December, 2015
- Allows for states to transition into 2017-18 school year
- Carries forward standards, annual assessments, accountability, and subgroup disaggregation
- Gives greater control to states and districts in the areas of accountability, school improvement, and teacher support and evaluation
- Emphasizes transparency through increased public reporting (programmatic and fiscal)
- Places new or expanded emphasis on supporting and reporting on performance of particular groups of students (ELs, homeless, foster care, students of military families)
- Eliminates some discretionary grant funding, re-channels some funding, and newly emphasizes other priorities

## **SEA Plan Requirements**

- Each State is required to provide descriptions, strategies, timelines, and funding sources, if applicable, related to implementation of the programs included in the consolidated State plan
- Address the requirements for the following five components and corresponding elements of the consolidated State plan:
  - Consultation and coordination
  - Challenging academic standards and academic assessments
  - Accountability, support, and improvement for schools
  - Supporting excellent educators
  - Supporting all students

## Developing the SEA Plan: OSSE's Timeline

- August: launch of public engagement plan, surveys
- September: internal analysis of law and survey results
- October: analysis of survey results and external focus groups
- November: drafting of the plan
- December: review of draft plan
- January: posting of plan for public comment; community meetings with SBOE
- February: finalization of plan; vote by SBOE
- March: submission of plan to USDE

## **Community Schools: Community of Practice**

OSSE, in partnership with key stakeholders, is launching a Community of Practice (CoP) in 2016-17 school year. The CoP will offer an opportunity for all District of Columbia schools to receive training and technical assistance in creating and sustaining a community school.

#### **General Framework of Meetings**

- Frequency of meetings
  - One meeting per month (September 2016- May 2017)
  - Two-hour meeting
- Structure of meetings:
  - First hour Introduction to topic; sharing of theories on topic
  - Second hour Practical application of topic and network opportunities



## **Community Schools: Community of Practice**

#### **Fall 2016 CoP Meetings**

#### Sept. 29, 2016: Setting the Stage for a Community Schools CoP

This session will focus on the introduction of OSSE's first CoP, creating a mission and vision for the CoP, introduction to community schools and an introduction to key tenets to consider when creating a community schools.

#### Oct. 27, 2016: Start Up/School Administration Buy-in

This session will focus on areas to consider when starting up a community school (e.g., relationship building with a collaborative approach, communication styles and goal setting and alignment). There will also be a panel discussion for participants to hear from best practices that exist in the field.

#### Nov. 30, 2016: Evaluation/Data

This session will focus on how to use evaluation/data to inform practice (i.e., How to access and assess national and local data trends as well as OSSE community schools evaluation report to strengthen DC community schools). There will also be a panel discussion for participants to hear from best practices that exist in the field for this topic area.

#### Dec. 20, 2016: Partnership Building

This session will focus on partnership building (i.e., why are partnerships essential to community schools?), taking an inventory and determining school needs, and building a collaborative partnership. There will also be a panel discussion for participants to hear from best practices that exist in the field for this topic area.
