

2023-24 Assessment Policy Reminders

Assessment Policy Reminders

- The Office of Assessments annually publishes the <u>Statewide Assessment Participation</u> <u>and Performance Policy</u>. The document contains information about required assessments and details OSSE policy in several areas including:
 - English Learner Requirements and Participation
 - Students Recently Arrived to the United States
 - Students Taking Advanced Middle School Mathematics
 - Statewide Assessment Participation Rate Calculation
 - Statewide Assessment Performance Results Calculation
- Review the policy guidance to ensure compliance with the guidelines and administration fidelity.



Test Security



School Test Security Plan

- OSSE requires every school, including nonpublic schools, that will administer a statewide assessment to complete and submit a School Test Security Plan prior to the start of the school's testing window.
- The School Test Security Plan serves as an official communication with OSSE of a school's plan for administering statewide assessments.
- The <u>OSSE Assessment Portal</u> application, through which School Test Security Plans are submitted, is now live.
- School plans must be submitted to OSSE for final approval at least 15 business days prior to the first day of testing.
 - Start and end dates for ACCESS for ELLs were due no later than Jan. 23, 2024.
 - Start and end dates for MSAA and DLM were due no later than Feb. 12, 2024.
 - Start and end dates for DC CAPE are due no later than Mar. 4, 2024.



Incident Reports

- Incident Reports for all 2024 Assessments can now be submitted directly in the <u>OSSE Assessment</u> <u>Portal.</u>
 - Please do not submit Incident Reports in the OSSE Support Tool. To submit reports, access the attached guide for support.
- Notifications for all Incident Reports will go directly to the point of contact who submitted the School Test Security Plan.
- Make sure to follow your internal process to notify all necessary LEA personnel of any Incident Reports, and print the Incident Report for your Test Security File.
- Anonymous reports may be submitted using this link.
- Adjustments made to the School Test Security Plan or the Testing Schedule are considered minor deviations and may be updated in the School Test Security Plan app. They are not classified as incidents.



2023-24 Assessment Monitoring

- OSSE monitors **all** statewide assessments in person. OSSE selects schools for onsite monitoring primarily based on random selection.
- Assessment Monitoring begins with ACCESS administration in February and continues through the end of the DC CAPE window in May.
- OSSE will not notify schools that have been selected for assessment monitoring and may visit a single school site for multiple assessments.

ACCESS for ELLs Activities

ACCESS for ELLs and WIDA Alternate ACCESS

- Test window: Feb. 12 March 22
- LEAs should log in and verify student registrations and accommodations before beginning testing.
- Additional Materials order window opened Feb. 6
 - Orders must be placed by LEA test coordinator and shipped to individual schools
- Refer the OSSE <u>ACCESS Readiness Guide</u> for high-level activities related to administration and the resources available on the <u>WIDA Secure Portal</u>.



MSAA and DLM Updates

DLM Registration and Overview of Tasks

- OSSE will begin enrolling eligible DLM students in grade 5 and grade 8 the week of Jan 15.
 - LEAs and nonpublic schools are responsible for enrolling eligible high school students for the DLM assessment.
- Key dates and additional process details are shared below:

Dates	Action
Jan. 15 – Feb. 2	OSSE enrolls grade 5 and grade 8 eligible students; LEAs and nonpublic schools enroll eligible HS students
Jan. 15 – Feb. 2	DLM LEA Test Coordinators add/update accounts for users in their LEA in Kite Educator Portal
Jan. 25	DLM Test Administrator Training – Session 1 (virtual Teams meeting)
Feb. 5 – Feb. 16	OSSE rosters grade 5 and grade 8 eligible students; LEAs and nonpublic schools' roster eligible high school students
Feb. 16	DLM Test Administrator Training – Session 2 (virtual Team meeting)
Feb. 19 – March	Test Administrators complete First Contact Survey and Personal Needs and Preferences (PNP) prior to testing *Reminder – student First Contact Survey and PNP must be completed at least <u>one</u> day prior to the start of testing. Testlet creation takes 24 hours upon completion.
March 11 – April 26	DLM Administration Window



Reminder: DLM Required Test Administrator Training

New for 2023-24: Educators with the Teacher role will need to access the DLM Required Test Administrator Training in the training section of <u>Kite Educator Portal</u> for the 2023-24 school year.

- Users who have a Kite account and the "Teacher" role assigned will be automatically enrolled in the training and can access the training via the training tab.
 - Newly created accounts will be enrolled in the training within about 30 minutes after their accounts are activated.
- New Test Administrators are still expected to pass each of the four modules with a score of 80 percent or higher.
 - Returning Test Administrators are still expected to pass one module with a score of 80 percent or higher.

MSAA Updates

- Students who are eligible for MSAA have been registered by OSSE in the MSAA System
- LEA Test Coordinators should have received a welcome email from the MSAA System on Tuesday, Feb. 20
 - LEA Test Coordinators are responsible for creating Test Administrator accounts
 - Nonpublic School Test Coordinators can reach out to <u>OSSE.Assessment@dc.gov</u> to gain access to the appropriate students in the MSAA System



MSAA Training Requirements – Test Coordinators

- MSAA test coordinator training modules are housed in the MSAA system
- Completion of the training is required, but Test Coordinators do not need to take the final quiz

- MSAA test administration training modules are housed in the MSAA System
- Each training module includes a required end-of-module quiz
- The final quiz must be passed with a score of **80 percent or higher**


DC CAPE Updates

- The ADAM platform is open to LEA Assessment Managers as of Friday, Jan. 19. LEA test coordinator accounts were created only for individuals listed as the LEA Assessment Manager in AllStaff.
- Nonpublic school test coordinators should also update their designations to LEA Assessment Manager in the Nonpublic AllStaff collection. Reach out to <u>OSSE.callcenter@dc.gov</u> for assistance with this process.
- We anticipate releasing the DC CAPE Accessibility Features & Accommodations (AF&A) Manual and Test Coordinator and Test Administrator Manuals in late February. These documents will be posted on the <u>Pearson Support Portal</u>.
- Pearson is developing reference guides to support specific tasks/processes LEAs will need to complete in ADAM. These guides are available on the <u>Pearson Support Portal</u>.



DC CAPE Updates

- The discrepancies between the Accommodations Registration File (ARF) template in ADAM and the Accessibility Features and Accommodations (AF&A) manual have been reconciled. The ARF must be completed and uploaded by March 5.
