Mayor's Early Childhood Convening

- On June 9, 2016, Mayor Bowser convened thought leaders, partners, and practitioners in early childhood development to share her vision for early childhood in the District of Columbia and to hear what is working well, what is not working, and where there are opportunities to improve early care and education in the District.
- Participants engaged with one another to brainstorm strategies to further improve upon the District's work as a national leader in early childhood education.
- Participants worked in small groups in order to identify challenges and opportunities for improvements to better enable providers, families, and children to access affordable, quality early care and education in the District.

Proposed Child Development Facility Licensing Regulations



Purpose of Proposed Licensing Regulations

- The overarching purpose is to ensure that care provided in a licensed facility is not only safe, but also supports children's healthy development and future academic achievement and success.
- The proposed rulemaking will align the District's regulatory framework for Child Development Facilities with the Child Care and Development Block Grant, effective November 19, 2014 (CCDBG) (P.L. 113-186; 42 U.S.C. 9858 et seq.) and the Child Care and Development Fund (CCDF).
- These new requirements reflect current research that demonstrates how stable, high quality early experiences can positively influence early childhood development and contribute to children's future success.

Timeline*

- Publish Proposed Child Development Facilities Regulations in DC Register Sept. 2.
- Public comment Sept. 2-Oct. 3.
- Final Rulemaking Nov. 18.

Pre-K Enhancement and Expansion Framework

- The Pre-Kindergarten Enhancement and Expansion Funding program is managed by OSSE pursuant to the Pre-k Enhancement and Expansion Amendment Act of 2008 (the "Act"), effective July 18, 2008 (D.C. Law 17-202; D.C. Official Code §§ 38-271.01 et seq.) and its implementing regulations, 5-A DCMR Chapter 35.
- The Pre-K Enhancement and Expansion Funding program is a multipronged initiative aimed at creating and supporting high-quality universally available pre-kindergarten ("pre-K") education services in the District of Columbia through a mixed delivery system in community-based organizations (CBOs), District of Columbia Public Schools, and public charter schools.
- The implementation of the Act is a central part of OSSE's mission and goal to ensure that all children are well prepared for school and that our youngest learners receive an excellent education.

Pre-K Enhancement and Expansion Funding

- OSSE seeks to enhance funding for current high-quality pre-K education services offered by CBOs to ensure program quality is maintained by maximizing multiple funding sources.
- A Notice of Funding Availability (NOFA) for fiscal year 2016-17 for the Pre-Kindergarten Enhancement and Expansion Funding was published in the *D.C. Register* on Friday, June 24, 2016.
- Eligible applicants include CBOs that are currently rated Gold in the Quality Rating and Improvement System.
- The high-quality designation application was provided to all interested parties during the mandatory pre-application conference at OSSE on **July 1** and **July 11**.
- High quality designation applications are due August 1. Applicants will be notified August 8. Funding applications are due August 30.

Quality Facilitators for DC's Enhanced Quality Rating and Improvement System (QRIS)

A Notice of Funding Availability (NOFA) for Quality Facilitators was published in the *D.C. Register* on Friday, July 15. The Request for Application (RFA) will be released August 10. A pre-application meeting will be held Aug. 17, 2016 at OSSE from 10 a.m.-12 p.m.

- The purpose of funds provided is to support the District's enhanced QRIS.
- The Quality Facilitators will work alongside the program director, principal, curriculum specialist, or designated on-site administrator (OSA) to offer guidance and continuous quality improvement support through regular visits, communication, and technical assistance.
- Eligible applicants include public agencies, not-for-profit, for-profit, and faith-based organizations.

- Eligible applicants include public agencies, not-for-profit, for-profit, and faith-based organizations.
