	Question and Answer Period: 1. How much compensatory education time is being offered to students with disabilities as a result of COVID-19? An individualized determination whether compensatory services are needed must be made under applicable standards and requirements. The IDEA does not specifically address compensatory services, as such compensatory services were developed by courts as an equitable remedy for denials of FAPE. However, LEAs have broad flexibility through the IEP Team process to discuss and make an individualized determination with regard to what compensatory services are needed and how they should be provided. Compensatory services can come in many forms. For example, an IEP Team could decide that the student needs compensatory services before or after school or on the weekends. Or the IEP Team could decide to increase the student's IEP hours or services for a time-limited and time-certain period.
	2. Is OSSE looking into long term plans to address needs of students with special needs if some of the changes we are experiencing during COVID 19 leads to permanent changes in the way education is delivered? OSSE recognizes LEAs and schools are operating in a rapidly changing environment with unpredictable timeframes. This is something that we have thought about. 	 Question and Answer Period: We would like to hear about best practice around ESY for students this year. Does OSSE have a plan to address this? OSSE differed on FAQ's published and explained to SAPSE that we will vet this upward to leadership, however, ESY is a decision for the IEP team to make. For note purposes, to reiterate the difference between compensatory education and extended school year services (ESY) and Compensatory services, which are intended to put the child in the position he or she would have been in had the LEA provided the services in the first place (Reid v. Dist. of Columbia, 43 IDELR 32 (D.C. Cir. 2005)), are separate and distinct from extended school year (ESY) services, which are intended to prevent significant loss of the benefits gained during the regular school year during school breaks (OSSE ESY Policy p. 2-3, March 10, 2011). However, this would not prevent the IEP Team from adding compensatory services into the student's regular ESY programming, as long as they do not interfere with it. The IEP Team can also decide that the LEA will provide compensatory services to student at the same time and place the LEA is providing ESY services to other students. Additional guidance on ESY certification is forthcoming. SAPSE would like to know if students are getting letter grades and what promotions look like for students. There is some guidance from DCPS (only DCPS) about grading which came out from the Chancellor on 4/29/20.
